Sub: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby intimate your goodselves that the Company was declared the L1 (Lowest) Bidder, in Joint Venture with Jakson Limited, for Jharkhand Urja Sanchar Nigam Ltd and U P Power Transmission Corporation Ltd; and, in Joint Venture with Vihan Enterprises, for MPPTCL projects. The Bid Amount for the said Projects is Rs. 1,479.53 Crores. BS Limited was declared L1 (Lowest) Bidder for Rs. 157.05 Crores, while Bids worth Rs. 824.97 Crores are under process and Bids aggregating to Rs. 497.51 Crores were lost.

 - Construction of (2X40MVA), 132/33 KV Substation Nawabganj (Gonda).
 - Construction of 220/132/33kV S/s Bachrawan Raibareilly and 220/132/33kV S/s Amethi Substation.
- Won Bids aggregating to Rs. 66.81 Crores, in Joint Venture with Vihan Enterprises, from MP Power Transmission Company Ltd. for:
 - Construction of 33/220 kV Pooling Substation at Badwar along with Associated 220 kV DCDS Transmission line (Route length 3Kms.)
 - Construction of 33/220 kV Pooling Substation at Barsita Desh along with Associated 220 kV DCDS Transmission line (Route length 1.5 Kms.)
 - Construction of 33/220 kV Pooling Substation at Ramnagar Pahad along with Associated 220 kV DCDS Transmission line (Route length 3.5 Kms.)
