Dear Stakeholders,

It is to inform you that following classes of creditors eligible to nominate their representatives from their class as per Regulation 31A of IBBI (Liquidation Process) Regulations, 2016 to constitute the Stakeholder's Consultation Committee subject to the maximum number of members of that particular class.

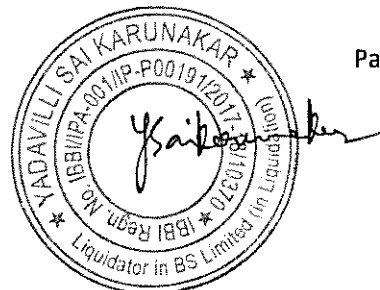


